INVITATION TO BID

Sealed bids for MassDOT approved Mass Top bituminous concrete will be accepted by the Chief Procurement Officer on **Wednesday, July 19, 2017** at the Egremont Town Hall, Selectmen's Office, 171 Egremont Plain Road, Egremont MA 01230. Bids must be sealed and clearly marked "Bid-Bituminous Concrete-Baldwin Hill-West". All bids will be opened and read aloud at the above posted place at 1:00 P.M.

Work consists of approximately **311** tons of 1 1/2" MassDOT approved Bituminous Concrete Top in place including all machinery and manpower, including approximately 415 tons of 2" binder and approximately 185 gallons of tac coat, cutting of key ways, and milling. Work to be completed by the end of September 2017. Work to be done on Baldwin Hill-West in Egremont.

No bidder may withdraw their bid for a period of thirty days, excluding Saturday, Sundays, and Holidays, after the actual date of the opening of the bids.

The successful bidder must furnish a 100% Payment Bond, and furnish proof of Insurance for General Liability, Auto Liability, and Workers' Compensation. All bids must be accompanied by a Statement of Non-collusion. Each general bid shall be accompanied by a bid security in the amount of 5% of the bid price.

The minority employee percentage rate to be applied to this project will not be less than 5% in each class.

Vendors must be pre-qualified. Contractor's intending to bid on this project must first obtain Forms CSD-681 "Request of Proposal Form" from: Commonwealth of Mass., Department of Public Works, Contract Engineer, Room 6260, 10 Park Plaza, Boston MA 02116-3973. This form must be completed and submitted to the Contract Engineer for approval. Only those who have obtained an "Approval for Proposal Form" will be allowed to bid in this project.

Wage rates are subject to the minimum wage rates as per M.G.L. Chapter 149, Section 26 to 27F, inclusive. A copy of the wage rates may be obtained at the Board of Selectmen's Office. In accordance with M.G.L. C49, S27B, a true and accurate record must be kept by all persons employed on public works projects. Every contractor and subcontractor is required to submit a copy of their weekly payroll records to the Board of Selectmen. Forms are available at the Board of Selectmen's Office. Each such contractor and subcontractor or public body shall furnish to the Executive Office of Labor within 15 days after completion of its portion of the work at statement, executed by the contractor, subcontractor or public body supervising the payment of wages, in a form available at the Board of Selectmen's Office.

All bidders must possess 10 hour OSHA card. All work and materials must comply with MassDOT State Specifications.

Bidders must conform to the monthly price adjustment for hot mix asphalt (HMA) mixtures as per special provisions of the MassDOT Document 00811. See www.massdot.state.ma.us for period prices. Current base price is \$410.00 per ton. Bidders must conform to price adjustment clauses for diesel fuel, gasoline, liquid asphalt, Portland cement concrete, structural steel and reinforcing steel. Current base price for diesel \$1.953 as listed for May, 2017.

The Selectmen reserve the right to waive any informality. The Selectmen reserve the right to reject any and/or all bids deemed to be in the best interest of the Town.
