Rules and Regulations for Use of French Park

Reservation requests for the use of the pavilion and/or the band stand must be made to the Office Staff for such things as birthday, anniversary, wedding parties, reunions, etc.

Reservation requests for the little league field, volleyball court, horse ring, basketball court, tennis court, or Babe Ruth ball field must be made to the Office Staff. Reservations for fund raising events must be made to the Trustees in writing.

Reservations for the WHOLE PARK, or a large portion of the park WILL NOT BE ALLOWED. Your reservation allows use of only the specific area requested (i.e. pavilion) and the Park will remain open to the public at all times.

Insurance certificates will be required for large groups using the park showing liability coverage in the amount of \$1,000,000.00 (e.g., groups holding fund raisers, horse shows, ball games)

The park must at all times remain freely open to the general public.

No events that charge an admission fee to the park or for parking will be allowed. Admission to events being held in a certain area of the park will be allowed.

All dogs must be kept on leashes unless enclosed in the dog park. All dog droppings must be cleaned up by owner and removed from the Park.

Horses are only allowed in the open area of the Park between the Little League Field and the road, in the horse ring and the surrounding area, along the tree line to access the trails, on the trails, and in the wooded areas of the Park. Horses are <u>not allowed</u> in the area of the playground, the ball fields, and the pavilion. All horse manure must be cleaned up by the horse owner and removed from the Park.

Garbage <u>must</u> be placed in proper receptacles. Recycling is mandatory. Recycling barrels are located in the park and clearly marked. No glass containers are allowed on the premises. If your event will have music, an attempt should be made to notify abutting homeowners.

Park Hours are from <u>Dawn to Dusk</u>. Special events may receive permission to be on the premises until 10:00PM.

The Trustees/French Park Committee reserve the right to approve or deny any reservation request.
